NON-RESIDENTS FEES

- For a person whose permanent place of residence at the date of death was not within the Civil or Ecclesiastical Parish of Sawbridgeworth will be quadrupled, except that a person whose permanent place or places of residence for five of the ten years immediately preceding the date of death was within the said Civil Parish.
- Where the permanent place of residence of either parent of a still-born child was not within the Civil or Ecclesiastical Parish of Sawbridgeworth will be quadrupled.

N.B.

- Headstones only are permitted in Sections G and F of the Cemetery
- Cremation tablets are only permitted in Section H of the Cemetery
- Headstone with kerb sets are only permitted in Section J of the Cemetery
- Pre-purchase of plots is not permitted
