A18/24 ALLOTMENTS

To report on matters relating to Allotments

- Allotments Manager reported that she was preparing a schedule of works to be carried out in the spring.
- Water consumption now being monitored on a site by site basis preparatory to making realistic, relevant water charges to tenants.
- Waiting list remains at 9, no new tenancies having been offered since the last meeting of the committee.
- Future developments Clerk mentioned that the Bellmead site had become blighted by the juxtaposition with the new building development in Springhall Road. He suggested a future plan for utilising the site if it became de-allotmentised in favour of the introduction of a West Road site

A18/25 CEMETERY

To report on matters relating to the Town Cemetery

Inspections

o Compliance with Regulations, attempt made to confirm that we were compliant by:

 Training course at LCPAS, which was also designed to assess a potential new source of training, was cancelled!

Maintenance

- Sub-contractors, we have now established relationships with new grave digging contractors which are proving an improvement.
- Automatic watering bags have been acquired which will ensure new trees become established, even in dry weather.

Development

- Roadway Extension, still need further quotes, matter in hand
- Marketing, considering possible tree layouts, rose gardens and a research visit to Greenacres Epping Forest to investigate woodland burials.
- The Spinney, waiting for cost estimates for clearance and inspiration for how best to use the asset.

A18/26 FOOTPATHS & OPEN SPACES

To report on matters relating to Footpaths and Open Spaces

- Bullfields
 - Current situation
 - Play equipment is now being inspected and maintained by the Management Committee.
 - Litter clearance is being arranged directly by the Management Committee.
 - Grass cutting will be carried out under contract against specific orders from the Management Committee.

West Road

- Inspection and maintenance
 - Play equipment, inspected weekly. Considerable vandalism is apparent and will have to be repaired, estimated cost will be around £3,000.
 - Litter clearance is carried out twice a week and on demand.
 - Grass cutting is carried out by the Ranger on a routine basis.

Other areas

- London Road flower beds
 - Maintenance has been carried out by a combination of the Ranger and Oakridge Nurseries.

Town Green

- Update report. Contact with EHDC and support for a grant application to Pocket Parks Plus to enable development.
- Maze maintenance was specifically addressed and the repair and maintenance will be discussed with EHDC.

Fair Green

- Development. No further progress on this site.
- Maintenance. Carrying out periodic grass cutting.

Footpaths

- Elmwood. Contract awarded to Honours for the clearance and restoration of the footpath. Investigation into whether this can be established as a Right of Way.
- Parish Hall. Contract awarded to Honours for the restoration of the footpath
- Rivers Heritage Orchard
 - Update report on licencing obligations. Continuing dialogue with the landowner and agreement on maintenance and hedge work. These being funded by the landowner.
 - Volunteer group conducted a Wassail event without assistance from council officers. We did however lend them our fire bowl for the occasion.

A18/27 OPERATIONS

To report on matters relating to Operations

- Community Transport
 - Sawbobus. Continues in service but FIAT vehicle shows a multitude of faults. Negotiating with Mellor and FIAT to rectify.
 - Hire minibuses. Are used on a regular basis, lent one to Bishops Stortford under our reciprocal arrangement. One vehicle maintained to provide back-up for Sawbobus.
