- Hertfordshire Police PC Ray Larcombe reported:
  - o 14 crimes in the month
  - o 2 convictions for burglaries
  - Liaison with Clerk for next policing priorities
- Footpaths Officer Cllr Brian Rochester reported:
  - o Boardwalk repaired with help from the Town Ranger
- Other Representatives

    - play schemes starting in the summer
    - East Herts and Broxbourne CVS used furniture scheme
  - O Clir Mortimer reported:
    - That he would reintroduce himself to the Duckling Centre
  - Cllr Wincott reported:
    - Progress at the Memorial Hall, windows and doors replaced; substantial work on the roof with the objective of finishing in time for the Allotments Show on 01 September.

#### 12/54 FARMERS MARKET

To report on the progress towards the re-launch of the Sawbridgeworth Farmers' Market in September 2012. New equipment has been ordered and is scheduled to be delivered in the last week of August. Revised publicity has been arranged. One member suggested that the market should be changed to a Sunday to help retailers.

#### 12/55 CIVIC CENTRE

To report on the progress towards the creation of a Civic Centre for the benefit of the parishioners of Sawbridgeworth. Some issues have been experienced with the infrastructure but steel work and above ground works will commence very shortly. Programme is approximately on schedule.

#### 12/56 BELL STREET CAR PARK

To report on the progress towards the launch of the new parking scheme in the Bell Street car park on Monday 06 August 2012. All publicity and technical arrangements are now in place ready for the launch. Final road remarking and labelling is taking place immediately before the launch.

#### 12/57 FLY POSTING

To report on the first month's operation of the agency agreement with EHDC on the regulation and removal of unauthorised Fly Posting in the town. Consistent application is being made to the task with a large degree of success.

- Members' Pecuniary Interests Members are reminded that they should complete the new declaration of interests form that they have, and return them to the Clerk.
- External Audit. The Annual Return with its accompanying papers has been sent to the external auditor within the required time frame.
- Minibuses. The small minibus has now been repaired.
   The new conditions of hire have been issued to all regular users.
   The Clerk is in discussion with BSMT to secure a more equitable relationship with them in respect of the Sawbobus operation.
   The latest quarterly review will have taken place and we are now working on the possible revision of services and schedules which may be necessary or desirable to offer an enhanced service to our parishioners.
- CCTV. We have now received planning consent for the second of the pair of cameras from EHDC. We will now refresh the quotations received for the installation and monitoring of the system.
- Security Cameras. Cameras recommended by Herts Police have been purchased and are waiting installation, initially at the Bullfields Centre and also at West Road. Further locations will be identified in conjunction with our neighbourhood policing team.
